- Filing 6 1362 South Pierson Court: Trailer in front driveway.
  - Action: First letter sent 8/7/2019. Covenant issue is resolved. The trailer has been sold, and removed from the property.

#### Filing 4 - 10923 W Mexico Drive: Trailers in driveway

- Action: Chris Mengels, the property owner attended this meeting explaining that he would like an extension of time to build up the side of the property to allow him to put the trailer in the back yard. He is in the process of obtaining a building permit to build a retaining wall to allow this process to happen.
- The board tabled any additional action for 6 months pending monthly documentation showing progress toward meeting the covenants.

### Filing 4 - 1660 S. Parfet Court: Commercial Trucks and Trailers on property

Action: Earl reported the latest violation to Jefferson County Zoning. WELCA needs a
complaint in writing to start a new Filing Number 4 covenant violation letter. Jefferson
County does not have a repeat offender penalty, and this is the third time this year the
Commercial Vehicles are stored on the property

#### Filing 6 - 11445 W Florida Place: Weeds and Sumac growing in side yard.

- Action: Issue resolved at the time of this meeting. The Homeowner/Renter mowed the Sumac saplings and weeds.
- Filing 6 1503 South Queen Street: Trailer parked in driveway.
  - Action: The renter moves the trailer from the driveway every other week for 7 days, and meets the covenant requirement. No violation at this time.
- Filing 6 1508 South Queen St. Weeds and branches growing into roof, junk in front yard.
  - o Action: WELCA has reported this to Jefferson County Zoning.
- Filing 4 1820 South Parfet Ct. Trailer parked in driveway.
  - o **Action:** Mike / Earl will talk to them, concerning the covenant violation.
