Sign Discussion

1. Political Campaign / Election sign Guidelines for homeowners

- Jefferson County has sign limitations and sizes but not on content. Waiting on Jefferson County to reply back with their rules or guidelines.
- Colorado State Law Colorado Common Interest Ownership Act (CCIOA) permits homeowners to display campaign/elections signs that override any HOA or Civic Association (CA) rules against any display of election type signs.
 - CCIOA allows campaign signs to be displayed a minimum of 45 days before and 10 after an election. HOAs and Civic Associations can lengthen this time frame.
 - CCIOA permits the Association to regulate the size and number of signs and allows for one election/campaign sign per political office, or ballot issue.
 - State has 3ft. x 4ft. guidelines but HOA or CA to modify sign dimensions or follow County Rules.

Motion: To modify WELCA uniform rules (guidelines not covenants) to allow for election/campaign political signs for a period 120 days before and 10 days after an election with signs that comply with County and State regulations.

• The Motion passed by a vote of: 8 -for and 1-opposed

2. Other Non - Election/Campaign Signs

- Waiting to hear back from our attorney and Jefferson County for County Rules before making any change, but the general consensus was:
 - One Sign allowed
 - No Business or Advertisement allowed
 - No Hate language

- No Profanity
- Professional Quality
- 4 square ft. maximum

Motion: Provide a letter approving a temporary "Black Lives Matter" sign, which complies with County rules to Amanda & Torrey Purnell.

The motion passed unanimously
