Covenants & Violations:

- Filing 9 11455 West Texas Avenue: Clutter remains in driveway and in the yard.
 - o **Action:** A certified letter has been sent, asking for clutter to be removed.
- Filing 4 1660 S. Parfet Court. The Commercial Trucks and Trailers stored on property.
 - Action: Earl is working with Jefferson County Sheriff and Zoning. WELCA will needs clarification from HOA lawyers on a couple of violations on this property.

- Filing 4 10923 W Mexico Drive: Trailers in driveway
 - Action: Trailer has been sold. This is no longer an issue. WELCA Board will send
 notification to Homeowner, that this issue is considered resolved and the homeowner
 has as much time as required to build a covenant compliant storage area.
- Filing 6 1503 South Queen Street: trailer being stored long term parked on driveway
 - Action: A certified letter was sent to home owner asking to move trailer behind a fence, or place the trailer in offsite storage.
- Other Filing 6 and Filing 7 A list of covenant violations from these two filings was emailed to the WELCA website. WELCA will check into the violations and proceed to write letters etc. if they are violations and continue to be problems. The issues seem to be boats, campers, trailers etc. being stored on driveways or on the street.
- Florida Avenue/Union Blvd Traffic Signal (City of Lakewood)
 - Jim Foster attended a meeting with City of Lakewood, and the new signal will be installed mid to late summer.
 - WELCA sign will remain until July, when the City of Lakewood will take it down.
 - o WELCA will decide later this year the placement of a new larger sign.
