Some discussion regarding upcoming Fall Clean-Up.

A complaint was received by an anonymous member of our WELCA community which claimed that Board Meeting notes are "profiling" people in Lochwood. This complaint has been deemed unsubstantiated.

# **Covenant Issues:**

WELCA has received multiple Covenant Violation concerns recently. The following homes have received a letter from WELCA, primarily concerning yards that are unkempt and in need of water and regular care. They include: home in the 11400 block of W. Florida Ave., home in the 1800 block of South Parfet, and a home in the 1300 block of South Pierson Court.

A home located on the 11500 block of West Arizona Ave. was noted to have a large number of stored boats, and campers and these residents also received a letter regarding Covenant compliance.

A home in the 1800 block of S.Parfet continues to have a large amount of debris and trash in the yard, and this home is continuing to be monitored.

A home in the 1600 block of South Routt Way has a wrecked car in the driveway and these residents will also receive a letter from the Board

# VI) Old Business:

The new entrance signs for Lochwood have been completed and are now placed at our entrances to our community. They include our web site address. The signs look great.

The weeds along W. Florida Avenue between S. Kipling and S. Union are supposed to be the responsibility of Jefferson County. The county has stated they are struggling to hire contracted workers to address this maintenance issue. The county has said they will address this issue.
