Jean agreed to stay on in the capacity of Board President if others will assist in duties such as letter writing and tracking Covenant complaints received..

Board Secretary Amy Skinner made a suggestion to the Board that exact addresses not be used in the minutes when reporting Covenant violations in our WELCA neighborhood. Some discussion followed regarding whether or not to publish these addresses. A motion was made for the Board to vote on this proposed change. A vote was held and the majority of Board members voted to continue publishing addresses of Covenant violations.

VI Covenant Issues:

- 1870 South Parfet is well on it's way to being cleaned up. Some back-sliding of this property has been noted in the past, so monitoring will continue.
- 1606 South Robb Way-Cars are parked in driveway now, behind one of the wrecked cars. Next step is to call Jefferson County Zoning again.
- Arizona Avenue is once again full of cars and a large trailer. This includes several motorcycles in the yard and driveway. Zoning has been notified but is not returning Jean's calls.
- Neighbors can offer assistance in helping to correct the condition of properties in violation of our WELCA covenants.

Other Covenant violation letters sent and results- Lucidell

Addresses of the violations are:

- 1342 South Pierson Ct. weeds and a partial dead tree
- 1820 South Parfet Weeds and dead grass for a yard.

- 11577 W. Arizona Ave.: The exterior of the property looks much better. Car and boat in driveway continue to be an issue and will be addressed
- 11445 W. Florida Avenue: Weeds and Sumac seedlings in front yard.

Lucidell was not at tonight's meeting and so the most of the information regarding these violations was not available.

• Removal of weeds was done but never heard back from Zoning on who did the removal.

VI) Old Business:

The new entrance signs for Lochwood have been hung, with the exception of the two new signs that will be placed at the WELCA W. Jewell entrance. Either Dan or Andy will volunteer to hang these signs. The signs look great
