The WELCA Annual Meeting

As we come to the end of a year that many of us will not forget it is time to begin thinking about WELCA's Annual Meeting to be held in November. This year, due to the very important National Election we have moved our Annual Meeting back one week to November 10, 2020.

WELCA's Annual Meeting is a special time for the organization as it presents an opportunity to show the membership what has been done in the last year and what direction our Civic Association is taking into 2021. It is also an opportunity for the Board to get feedback from Lochwood homeowners on how the Association performed over the past year and also give ideas or input as to what homeowners would like to see changed or implemented in 2021.

One of the more important events at the Meeting will be the nomination and election of a new Board of Directors. Directors serve for a one year period with a new slate elected every year. It is possible for Board members to run for another term and several have indicated a willingness to do so. But a number of other current Directors have indicated they will not be returning. These are long serving members that really want to take some time off. Some of these members have served in excess of 20 years.

What Does It Mean to be a Board Member

The Organizational By-laws authorize a Board not to exceed 15 members. Currently there are 11 members who serve. Members are required to attend one monthly meeting that usually lasts for two hours. There are lesser duties, based on what the program for the year is but the actual commitment of time. Is about 30 hours a year.

What Are The Major Duties of a Board Member

The duties and responsibilities of a Board Member can be summarized as follows:

- Manage the monetary resources of the Association by developing a budget and assuring expenditures are within that budget
- Work with members to assure that covenants are followed and violations are corrected
- Participate in Community Projects
- Protect the value of property in the WELCA Community through enforcement of Covenants
